BONNIE BURKHARDT

Presentation Title: Criminal Violations of Fourth Amendment Rights during Investigations of Online Sex Crimes

Bonnie Burkhardt is a software engineer and President of her company, Blue Ridge Software Consulting. She has a security clearance and over 35 years of experience intercepting and analyzing signals for the Department of Defense. In addition to writing software, she has worked as a network protocol engineer, system administrator, and intelligence analyst. Because of her job duties, she has had over 100 classes on interception and privacy laws.

taught by the DoD. Ms. Burkhardt used her knowledge of these laws to expand her business into providing expert witness support to attorneys. With two cases, she wrote *amicus* briefs as a *pro se* litigant and submitted the briefs to the Appellate Court of Virginia. These briefs formed the basis for her book, "Manufacturing Criminals – Fourth Amendment Decay in the Electronic Age." Ms. Burkhardt was born and raised in North Dakota and drove her dad's combine during harvest season. She has a BS in Applied Math and MS in Computer Science and Engineering. She and her husband, Walter, moved to Virginia in 1989. They have grown daughters who were born and raised in Virginia. After becoming an empty-nester, she became active in politics and advocating for Fourth Amendment rights.



DR. AVON HART-JOHNSON

Presentation Title: "Leave Me Alone!"—I'm Cocooning

Dr. Avon Hart-Johnson is a social science researcher, author, and social justice advocate. She has authored numerous self-help books and peer-reviewed journal articles. She has co-authored a series of children's books on topics such as separation, loss, grief, and family member incarceration. Her latest publication "Children with Incarcerated Parents: Caregivers, Superheroes, and Silver linings" explores the family system impacted by incarceration and its potential impacts on child-development and ways to improve children's long-term emotional

well-being and overall health. This book will be released during the Fall of 2023. Dr. Hart-Johnson is a university educator, well-known keynote speaker, and social justice advocate. She chairs the Advocacy in Action Coalition, a national consortium of individuals and nonprofits focused on criminal justice reform. She is the vice president of the International Coalition for Children With Incarcerated Parents and serves as chief researcher for BiblioMethods (using literature and healing narratives to promote overall well-being). Dr. Hart-Johnson has a master's in forensic psychology, a master's in information systems management, and a PhD in human services counseling. She is a Certified Trauma Support Specialists (CTSS) and a Grief Recovery Specialist/Practitioner (GRS).



PROF. WAYNE A. LOGAN

Zoom Presentation Title: "SORN: Where It Has Been and (Perhaps), Where It is Headed."

Steven M. Goldstein Professor of Law at Florida State University, teaches and writes in the areas of criminal law, criminal procedure, and sentencing. He is the author or coauthor of several books, including The Ex Post Facto Clause: Its History and Role in a Punitive Society (Oxford Univ. Press, 2022) and Sex Offender Registration and Community Notification Laws: An *Empirical Evaluation* (Cambridge Univ. Press, 2021) (paper edition, 2022) (Ed., with J.J. Prescott). Professor Logan is also the author of several dozen law review articles, with

work appearing in such publications as the Georgetown Law Journal, the Michigan Law Review, the Pennsylvania Law Review, the *Texas Law Review*, and the *Vanderbilt Law Review*. His scholarship has been cited by the U.S. Supreme Court on two occasions and he is commonly quoted in national media outlets, including the A.B.A. Journal, the New York Times, USA Today, and the Wall Street Journal. Professor Logan is an elected member of the American Law Institute and a past chair of the Criminal Justice Section of the Association of American Law Schools. He has taught for over two decades, the last fifteen years at FSU Law. At

FSU Law, he has served as associate dean for academic affairs (2008-2011) and was awarded a University Graduate Teaching Award (2015). Before entering academia, Professor Logan clerked for the North Carolina Supreme Court and the U.S. District Court for the Eastern District of Virginia, and practiced law in Raleigh, North Carolina.



GALEN BAUGHMAN

Presentation Title: Guerrilla Tactics for Underdog Activists: The Future of the Insurgency in the War on Sex

Galen Baughman is a directly-impacted advocate based in Washington, D.C. dedicated to building a world where a person is not permanently defined by a crime of conviction. He was awarded an Open Society Foundation Soros Justice Fellowship in 2015 to build a movement to end the indefinite detention of youth in Virginia, which led to the first abolition bill introduced in the then-31-year history of pre-crime preventative detention laws in the U.S. Galen has spent 14 years of his life behind bars, including 6 years in solitary confinement, starting when he was just a teenager. Virginia has attempted to indefinitely detain Galen three

separate times past his release date — failing each time. Today, he is a highly sought-after speaker and campaign strategist on sex-related offense policy and the human rights implications of policy approaches public safety. He has also trained advocates around the country to build inclusive movements against mass incarceration. While incarcerated, Galen founded Just Future Project from behind the walls to dismantle systems of preventative detention, abolish shadow prisons, and advocated for policies that support restoration and reintegration of persons who have been in conflict with the law. After first winning his release in 2012, Baughman spent two years as the Director of Communications at International CURE, a grassroots advocacy organization, where he focused on policy analysis, direct advocacy, messaging strategies, and grassroots organizing. He was a JustLeadershipUSA 2015 Leading with Conviction Fellow. His essays have been published by Playboy Magazine, the Cato Institute, and others. Galen is on Twitter @GalenBaughman

The author of five books, Steve now serves as a consultant to Christian ministries. He specializes in strategic planning, board development,

fundraising strategies, organizational development, and grant-writing. He founded and led an inner-city ministry to the homeless in Oklahoma City for five years and was the State Director for the Oklahoma Partnership for Successful Reentry from 2011-2012. He recently worked for a national ministry in a grassroots advocacy role, recruiting and mobilizing Christian believers to be active in prison reform. He also serves as Chairman of the Board for Center For Jail Transformation.

Presentation Title: International Travel

Paul Rigney is executive director of registranttag.org, which is focused on registrants and their families' ability to travel internationally safely in a post International Megan's Law (IML) world. Currently, Paul is Program Director for Pecos Data Systems, LLC. He is a retired USAF Officer,, combat aviator and top gun graduate with 20 years in the USAF. Paul has 20 years experience as a certified program manager (PM) leading teams developing software for intelligence and DoD customers and cloud applications for commercial/B2B entities. In the USAF, he accumulated 2,000 flight hours in the F-111/F-4 fighter aircraft.

After retirement, Paul joined Raytheon Advanced Programs as a PM on advanced weapons development, UAS programs and command and control systems. In 2008, he accepted a 3 year Texas state charge for CP and enjoyed free room and board thanks to Texas DPS. Starting in 2011, he received an updated passport and has been dedicated to international travel. Presentation Title: Let's Move Toward Humanization and Person First

Jim Prager spent more than nine years in a Michigan Prison. After his release, Jim continued to live with the stigma of the registry. When he moved to Ohio in October 2003, he was assessed by the Sheriff's office as low risk; having to register once each year for ten years. In 2008 however, Ohio was one of the first states to become SORNA compliant. Suddenly, he was assessed as high risk with life-time registration and a requirement to register every three months, in person. In 2011, the Ohio Supreme Court ruled that the state could not change a

registry status after it had been previously assigned. In short order, Jim was then removed from the Ohio Registry. Over the years, Jim has become an advocate for more humane prison conditions. In 2011, he earned his license as a social worker. He now works with incarcerated individuals to help them prepare for release. He also facilitates support groups for individuals and families. And as time permits, Jim volunteers at "Prison CONversation" a small organization that helps people facing sexual conviction.

DR. FRAN BUNTMAN

Moderator

Fran Buntman's primary teaching and research interests focus on prisons and other institutions of punishment and power, especially in the United States and South Africa. A faculty member at the Department of Sociology at George Washington University (GWU) since 2002, she studies resistance and law to understand and change inequities and injustice. These themes are core to her book, *Robben Island and Prisoner Resistance to*

<u>Apartheid</u> (Cambridge, 2003) and her recent journal article "Prison and Law, Repression and Resistance: Colonialism and Beyond" (2019). She centers committed teaching and mentoring students along with a pedagogy that integrates theory and practice, including through <u>public engagement</u> and <u>advancing student-led policy change</u>. Dr. Buntman is an institutional leader; she serves as Sociology's Director of Graduate Studies and directs

the interdisciplinary Law and Society Minor which she was instrumental in creating. She has been recognized for her research, teaching, and advising work through multiple awards. Fran Buntman maintains an active research agenda, currently ranging from the manifestos of mass shooters to prisoner reentry. Born in South Africa where anti-apartheid politics and being Jewish shaped her life, she was educated at the University of the Witwatersrand, Brandeis University, and the University of Texas at Austin. She is now happily a 20-year resident of Washington, D.C., a proud mom of DC high school seniors, and grateful for a diaspora of family and friends.



VICKI HENRY Panel Member

Vicki Henry is the President of Women Against Registry. From "day 1" in that position, she has been (and remains to this day) the voice of registrants and their families. There is no task too large for this tireless advocate. Over the years, she has pled her case to State and Federal Congressmen, spoken to large and small audiences, planned conferences, helped to find housing for those in need, conducted support groups, been interviewed by national media personnel and so much more. One of Vicki's passions is to educate registrant family members

and supporters. This task, while slow and frustrating for some, can become an empowering and transforming effort. When successful, this effort can be satisfying and rewarding for the teacher and the student. In fact, Vicki takes every opportunity to educate on this topic; from lawmakers to prosecutors, to prison administrators to strangers in an elevator. Vicki is a true advocate who considers this work to be her calling. When she is not attached to her laptop or otherwise knee-deep in her life's work, she likes gardening, making fudge, searching Pinterest for ideas, and spending time with her family.



JANICE BELLUCCI Panel Member

Janice Bellucci is a civil rights attorney whose legal practice is limited to registrants and their family members. She has filed more than 100 lawsuits challenging California's registrant residency restrictions, proximity restrictions, school restrictions, Halloween requirements as well as a federal challenge to International Megan's Law. Janice earned her Doctor of Jurisprudence degree from the University of San Diego and has been recognized twice, as California's top 100 most influential attorneys. She is admitted to the U.S. Supreme Court, the 9th Circuit Court of Appeals, and every state and federal court within California. Janice

PAUL SHANNON
Panel Member

Paul was born in Boston in 1947 and has lived all his life in the greater Boston area. For almost all of his adult life he has been an activist, writer, and speaker in various peace, union, prison reform, human rights, and social justice movements, particularly the UnitedFarm Workers' union drives, the Vietnam anti-war and solidarity movements, the movement to end apartheid in South Africa, the 1980's Central American and Cambodian solidarity movements, the Haitian solidarity movement, the Afghanistan and Iraqi anti-war movements, and the effort

to end the war in Yemen. He is now retired from the New England Regional Office of the American Friends Service Committee where he worked for 40 years Paul taught social science courses as an adjunct instructor at a number of colleges for 42 years. And he is now a volunteer board member at several peace organizations. In the late 90's, Paul helped organize a broad coalition for all day hearings to oppose the original sex offender registry and lifetime civil commitment legislation in Massachusetts, and in 2007 he was a founder of the original Reform Sex Offender Laws (now NARSOL). He is on the board of directors of NARSOL and helps coordinate a loose network of advocates to oppose the sexual offense registry in Massachusetts.
